Pursuant to the Third Amended Plan of Reorganization, the above company will make a fourth payment of principal (\$7.597357) and interest (\$0.138599) on December 6, 2002 to holders of record on April 19, 2002. The distribution will quoted "ex" on December 9, 2002 and due-bills redeemable on December 9, 2002.

Since the notes have been dealt in flat, members are advised that effective September 24, 2002, trades executed in the notes should be on a **"reduced principal basis"** of \$860.6255306 in lieu of \$1,000 principal amount and "ex" the pay-down of \$7.735956 (\$7.597357 principal and \$0.138599 interest) per \$1,000 note. Comparisons and/or confirmations should be marked to indicate the reduction in principal.

Members are further advised that any future distributions will be paid to holders of record of April 19, 2002. Deliveries after the record date should be accompanied by due-bills representing any future payments. Please note that any future distributions will be calculated on a reduced principal basis.

Members should take immediate steps to adjust their records and bookkeeping systems to reflect the reduction in principal.
